BACKGROUND

On January 7, 1988, James C. Anderson for AFSCME filed a petition with this Board (PELRB) to modify the current certified Administrative Support Staff unit to include the following positions: Town Clerk, Tax Collector, Dog Officer, Assistant Building Inspector, Deputy Town Clerk, Deputy Tax Collector, Deputy Dog Officer and Administrative Assistant to the Public Works Director. When the current unit was certified, the above positions were either not in existence or were elected positions. Gary Wulf for the Town on January 11, 1988, by letter, in response to the petition objected to the inclusion in the unit of the following positions: Town Clerk, Tax Collector and Dog Officer on the basis that they were department heads and their duties were supervisory; the Assistant Building Inspector on the basis that the position is professional; the Administrative Assistant to the Public Director on the basis that the position is involved in labor Works negotiations and execution of any bargained agreement and fashioning of management proposals to the Union.

Hearing in this matter was held at PELRB office on April 21, 1988.

At the opening of the hearing Anderson for AFSCME amended the petition by dropping his request for inclusion of the Town Clerk, Tax Collector and Dog Officer and amended the petition to include in the unit the position of Plumbing Inspector. The Town did not object to this amendment.

AFSCME argued that changes in position duties and responsibilities had occurred with the change in Derry's government to that of Mayor and Council. AFSCME's request was finally narrowed to consideration of Assistant Building Inspector, Deputy Town Clerk, Deputy Tax Collector, Deputy Dog Officer and Administrative Assistant to Public Works Director and Plumbing Inspector. Testimony taken from witnesses, positions incumbents relative to job responsibility, supervisory actions, self-felt community of interests, participation in labor relations and testimony from a former occupant of the administrative assistant position no longer associated with the Town.

The responsibilities and duties of the various positions were explored in detail both before and after the change to the Mayor and Council form of Government.

Wulf for the Town in closing did not deny the positions' right to be part of a unit but was of the opinion that they should belong to a purely administrative unit. Derry does not now have such a bargaining unit.

ORDER

After considering all documents submitted and hearing testimony the Board finds as follows:

The unit is modified to include the positions of:

Assistant Building Inspector Deputy Dog Officer Plumbing Inspector

EXCLUDED from the unit: -

Deputy Town Clerk Deputy Tax Collector Administrative Assistant to Public Works Director

Gary Wulf for the Town on January 11, 1988, by letter, in response to the petition objected to the inclusion in the unit of the following positions: Town Clerk, Tax Collector and Dog Officer on the basis that they were department heads and their duties were supervisory; the Assistant Building Inspector on the basis that the position is professional; the Administrative Assistant to the Public Works Director on the basis that the position is involved in labor negotiations and execution of any bargained agreement and fashioning of management proposals to the Union. The Town does not contest the inclusion of the following positions; Deputy Town Clerk, Deputy Tax Collector and Deputy Dog Officer.
