**Modification of Certified Bargaining Unit**

Pursuant to RSA 273-A and PELRB Decision No. 2023-086 granting the City's petition for modification, the existing certification, set forth in PELRB Decision No. 2018-154 (September 7, 2018), is amended; and it is hereby ordered that the composition of the modified bargaining unit, represented by the International Union – UAW, Local 2322 for purposes of collective negotiations and settlement of grievances, is as follows:



The City of Nashua shall negotiate with the International Union – UAW, Local 2322 as exclusive representative on the terms and conditions of employment for the members of the bargaining unit and shall recognize the right of the International Union – UAW, Local 2322 to represent employees in the settlement of grievances.
