<u>Order</u>

On June 27, 2023, the PELRB issued an Order of Voluntary Surrender¹ to document the Teamsters Local 633 of New Hampshire's surrender of the certification set forth in PELRB Case No. M-0658 (November 15, 1999)(This certification describes the bargaining unit that is the subject of the election petition the State Employees' Association of NH, SEIU Local 1984 filed in this case). The caption in this case has therefore been amended to remove the Teamsters given this change in status. The case will now be processed as a request to approve a bargaining unit consisting of: 1) the positions previously represented by the Teamsters per the above-referenced bargaining unit certification dated November 15, 1999; and 2) the positions listed in the modification request in Case G-0114-3, all as listed on Attachment One to this order. The case will proceed according to the following schedule and deadlines:

1. Any objections to the case proceeding in this manner and/or to the composition of the above-described unit shall be filed on or before July 12, 2023.

- 2. The employer shall promptly file an employee list based on the positions listed in Attachment One to this order.
- 3. The State Employees' Association of NH, SEIU Local 1984 shall promptly file any additional confidential authorization cards it wishes to submit in support of the above-described unit.
- 4. The Town shall post this order in the workplace per the certificate of posting provided by the PELRB with this order.
