Agenda item #1:

The board reviewed the minutes of the previous meeting dated 10-22-2019 Motion made by Bob Hoyt: To accept the minutes as presented. Second by Stan Judge.

The course of the appointment will be as follows; Chairman Petrozzi will resign his seat as aerial lift representative and will be reappointed as the insurance representative to the board, then Brian Heon will be appointed to represent aerial lifts on the board.

Agenda item #2:

Proposed administrative rules final approval.

Heidi Barba informed the board that JLCAR at their November 21st meeting gave a conditional approval response to the proposed rule changes passed by the board. The board would need to approve this conditional approval and send it back to the JLCAR committee.

Agenda item #3:

Memorandum of understanding (MOU) with the USDA Forest Service.

Copies of the Forest Service manual chapters 7320 and 7330 specified in the MOU were provided for the boards review.

Chairman Petrozzi has been in contact with John Kamb from the Forest Service concerning the changes made to the MOU. Mr. Kamb informed Chairman Petrozzi the Forest Service is looking for the Tramway Boards DUNS Number. Discussion ensued regarding whether the board even had a DUNS number and/or where to find it.

Brian Heon thought as we take monies, we should have a DUNS number. Maybe look for the number from that angle.

Heidi Barba offered to do some research on this issue and report back to the board.

Stan Judge wants to be assured we are not obligating ourselves to administer Forest Service rules. He felt the language should be very clear concerning responsibilities of each party. Chairman Petrozzi made additional changes to the language of the MOU to address this concern.
