I. CALL TO ORDER

Item 1. Call to Order. The meeting of the New Hampshire Fire Standards & Training Commission was called to order by Chair Carrier at 9:00 a.m. on Thursday, April 5, 2012 at the Richard M. Flynn Fire Academy, 98 Smokey Bear Blvd., Concord, NH.

II. APPROVAL OF MINUTES

Item 1. *Motion* was made by Commissioner Burbank, seconded by Commissioner McGahey to accept the minutes of the January 5, 2012 meeting. Motion passed unanimously.

Chair Carrier spoke about the most recent Fire Officer class and how well it has been going.

IV. COMMITTEE REPORTS

Item 1. Emergency Medical Services. Commissioner Tetreault gave his report. A written report was submitted and was in everyone's packet.

Item 2. Fire Marshal's Office. Fire Marshal Degnan gave his report. No written report was submitted.

Item 3. Forest Protection Bureau. Commissioner Simpkins was absent. No written report was submitted.

Item 4. Curriculum Review. Curriculum Status Report by Chief Rosolen is in each Commission member's packet and is as follows:

CURRICULUM STATUS REPORT April 5, 2012

NFPA 1002 Driver Operator:**

Currently with the Commission approval classes in Driver Operator Pump will be scheduled to pilot in Moultonboro for April as well as Raymond in May. A new exam is being created to reference the new edition of the Delmar book.

NFPA 1030 Series:**

NFPA 1031, Standard for Professional Qualifications for Fire Inspectors and Plan Examiners. This program is scheduled for April and May in Littleton for the north country using an evening delivery with one Saturday. The program is doing well and we are breaking in new instructors.

A visiting committee for Inspector II has been advertised and awaiting your approval to begin. The only addition to this committee from the Inspector I committee is Deputy Fire Marshal Rob Farley.

NFPA 1021 Fire Officer:**

The spring class at the Academy has started this week, good reviews so far.

NFPA 1041 Fire Instructor:**

A number of classes are completed and one currently offered in Pelham. More classes will be scheduled shortly, one in the Lakes Region area and one at the Academy, an Instructor II-III is scheduled in Raymond as well to help in the prerequisite for Fire Officer I&II.

NFPA 1006 Rescue programs:

A number of rope, Confined Space and trench rescue programs are scheduled this spring and summer, and as well we are bringing back Rescue Systems I & II because of the federal grant that has been released from the 2007 2008 &2009 monies. As well a number of Swift Water rescue classes have been scheduled around the state. The rescue skills modules in FFII are also going to be offered around the state to aid in satisfying the pre requisite requirement.

NFPA 472 Hazardous Materials:

We have scheduled a number of Haz Mat programs such as Decontamination, Technician, and Technician refresher programs using the grant monies. We have partnered with the IAFF to assist with the refresher classes for instruction and program development.

Item 2. Program Updates. There was some discussion of the high school program in Dover. There have been no problems with it and it is consistently a good program.

The Director updated everyone on grant programs. The money is available for Haz-Mat programs, but if it is not used will go away as of the first of next year. Also, running the classes associated with these grants will not affect other classes normally being run (i.e., Fire Officer, etc.).

Swift Water Rescue is ready for Visiting Committee and there is a great need for this program.

VIII. NEW BUSINESS

Item 1. Instructor Evaluator Program Overview. There was a manual put together by Captain Rousseau in everyone's packets.

Item 2. Inspector II Visiting Committee. Motion was made by Commissioner Burbank, seconded by Commissioner Lyon to form this visiting committee with Commissioner Tetreault on it. Motion passed unanimously.

Item 3. Swift Water Rescue Visiting Committee. *Motion* was made by Commissioner Pratt, seconded by Commissioner Burbank to form this committee, with Commissioner Lindh on it. Motion passed unanimously.

Item 4. Fire Investigators Working Group. It was decided that Commissioner Tetreault will be on this committee also.

Item 5. Advanced Skills Program. It was decided this will be a 16 hour program.

Chair Carrier noted that there will be no meeting in May. The next meeting will be June 7th at 3:00 p.m. followed by the Criminal Justice and Public Safety Committee public hearing.
