NFPA 1001 Fire Fighter I&II

A visiting committee will need to be approved to begin the next standard change cycle.

NFPA 1031, Standard for Professional Qualifications for Fire Inspectors and Plan Examiners. Courses will be scheduled for the winter/spring semesters.

The Inspector II program will go back to visiting committee for review, possible thoughts of a stand alone and a combination Inspector I & II as well.

NFPA 1033, Standard for Fire Investigator.

A visiting committee is underway and the Jones and Bartlett curriculum has all ready been chosen; this committee is looking for an approval in the late winter/early spring.

NFPA 1021 Fire Officer:**

The next program is scheduled for the fall with on-line training involved. I have heard it is doing very well.

NFPA 1041 Fire Instructor:**

A number of classes are completed and more classes will be scheduled shortly.

NFPA 1006 Rescue programs:

A number of rope, Confined Space and trench rescue programs were offered this spring and summer as well, we are bringing back Rescue Systems I & II because of the federal grant that has been released from the 2007, 2008 & 2009 monies, both programs are going very well. The Swift Water rescue classes that have been scheduled around the state have very good reviews. This program will now be scheduled on a regular basis. The rescue skills modules in FFII are offered around the state to aid in satisfying the prerequisite requirement. All of these programs have been going well and large numbers of people are being trained. This program of the grant funds have now come to an end.

NFPA 472 Hazardous Materials:

We have scheduled a number of Haz Mat programs such as Decontamination, Technician, and Technician refresher programs using the grant monies. We have partnered with the IAFF to assist with the refresher classes for instruction and program development.

Rapid Intervention Program:

An Advanced RIT program is in visiting committee status.
