SPARC funding is intended to be used by CAHs to help address the health and well-being of the people who live in the communities they serve. As mentioned above, SPARC funding will be available to all CAHs throughout the state and through partnerships can be directed from the hospitals to EMS units to support MIH programs in their community. Description: The Department of Health & Human Services, Division of Public Health Services Rural Health and Primary Care and Chronic Disease Sections announce the availability of funds for Critical Access Hospitals (CAHs) to use for the implementation of strategic population health activities for rural communities (SPARC). SPARC funding is intended to be used by CAHs to help address the health and well-being of the people who live in the communities they serve. CAHs choosing to participate in SPARC will be provided with community data to help generate a plan for addressing the needs of their community. Strategies identified for implementation can be comprehensive and may include: 1) improving environments to make it easier for people to make healthy choices; 2) strengthening health care systems to deliver prevention services that keep people well and diagnose diseases early; and 3) connecting clinical services to community programs that help people prevent and manage their chronic diseases and conditions.

Potential collaborative partners: Area Emergency Medical Services (EMS) agencies, Diabetes Care and Education Specialists, Diabetes Education Program Coordinators, Pharmacists, Physical Therapists, Community Health Workers, Care Coordinators, Primary Care Providers, Regional Planning Commissions, Population Health Staff, Quality Directors, Quality Coordinators, EMS Medical Director, EMS Coordinator, Emergency Department Staff, Visiting Nurses Associations, Home Health Agencies.
