Dear Attorney Casco,

The property owners and residents of Bay Shore Yacht Club, Meredith NH, submit the following petition pursuant to RSA 270:12. We are requesting a hearing in order to relocate the "no wake zone" in Meredith Bay, further south in the bay.

Presently, the no wake zone per RSA 270:11 and Administration Rule Saf-C 5102 and the Town of Meredith Property Map, states: "(au) That part of Meredith bay in Lake Winnepesaukee running from an imaginary straight line as drawn from the Town of Meredith Tax Map U-2, Lot 7 southern boundary to Map U-15, Lot 48A southern boundary, to the northerly end of the bay on Route 25 shall be a "no wake" area"

Note: U-15 Lot 48A physical address is 29 Pleasant St and U-2 Lot 7 is 18 Bay Shore Dr.

We are requesting that the no wake zone be relocated to that part of Meredith bay in Lake Winnepesaukee running from an imaginary straight line as drawn from the Town of Meredith **Two hundred feet to the south Tax Map U-2, lot 11, of (26 bay Shore Drive) northern boundary**, to Tax map U-15 Lot 45B southern boundary (65 Pleasant St) to the northerly end of the bay on Route 25 to be designated "no wake" area"

In addition, we request that five buoys, be used to delineate the imaginary straight line drawn across the bay.

The reasons for requesting the relocation are attached:

Dear NH Dept. of Public Safety,

We the undersigned are contacting you on behalf of the owners and residents boaters at Bay Shore Yacht Club and Meredith Marina, regarding a serious problem here in Meredith Bay. There are 75 slips located here at BSYC. There is a serious safety, quality of life and environmental issues affect all of the families here at BSYC. We have the support of Meredith Marina in drafting this request for help, as it affects their safety at the fuel dock as well.

As you know, Meredith Bay is the most visited bay on the entire lake. There are thousands of boats that visit Meredith Bay on a weekly basis. It has created a situation which needs to be immediately addressed and we respectfully ask for your help in this matter.

The past six summers and continuing into 2016 have been the worst in as far massive wakes slamming vessels at BSYC and the fuel docks at MM. Boats here at BSYC have not been spared from the pounding, emanating from the wave energy. The relaxation and safety factors are gone. The wakes also have a negative impact on our shoreline.

Safety: The staff at Meredith Marina does an excellent job at the fuel dock. But the reality is that the wakes are slamming boats so hard up against the fuel dock that if an employee, a customer, or a child gets a limb caught in between the boat and the dock, they will lose that limb, **period**. If a fuel hose becomes dislodged from the tank it will contaminate the water. Mechanics who work on customers boats are getting tossed around inside the engine compartment as they cannot see the incoming wake.

Damage: Most of the boats are tied 6 ways in their slip, but there have been broken dock posts, (most recently July 2, 2016) , dock lines broken causing boats to bang of the docks, broken whip lines, damage done to the docks, as well the weakening of the entire dock structure system from the massive wave energy.

Quality of Life: Residents can no longer enjoy a meal, relax and socialize etc., aboard their vessels. On weekends the flow of boat traffic is constant all day until nightfall. When we leave or return to our slips, we have to time our exit/entry in between wakes, otherwise we'll get slammed. All of us have tied and retied other owner's boats. A Resident has been knocked off his feet and onto the deck, while tying up his boat. It's that bad.

Environmental: The wakes have eroded the shoreline. The sand and silt have backfilled into owners slips located along our shore. The vessels docked at those slips are in about 2 feet of water, as the lake starts to drain in late August. We have gotten two options on dredging those slips to remove 90 yds of silt. Option 1 would cost \$84,700. Option 2 would cost \$48,400. The challenge is that DES has limited the amount to be dredged at 90 yds. Quite frankly, 90 yds is not enough. Members are concerned that the dredging will not last more than a few years and that BSYC will have to absorb enormous costs every few years, if the wake/shore erosion is not slowed or mitigated.

In our years of observation, and in our opinion, the massive wakes are due to the fact that the present location of the no wake buoys, per: RSA 270:11 and Administration Rule Saf-C 5102, puts residents at BSYC and Meredith Marina in line with the massive wave generated by boats coming on and off plane.

We are respectfully requesting that the Meredith Bay no wake zone be moved south.
