

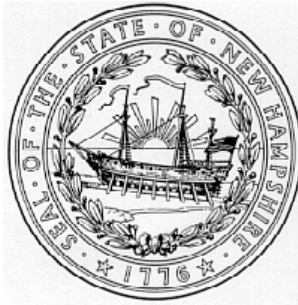

**ATTENTION ALL LOT OWNERS WITH LESS THAN FIFTY (50) FEET OF FRONTAGE:**

RSA 270:59 VIII(b) requires that lot owners with less than 50 feet of frontage must obtain written consent of the abutting property owners stating that the abutting property may be included in the frontage calculation. Such consent shall be signed by both parties, **notarized** and filed with the mooring application.

\*\*\*\*\*

**DO NOT SEND ANY FEE WITH THIS APPLICATION.** If approved, notification will be sent requesting the first time \$125.00 decal fee for each mooring. Your annual mooring decal(s) will be forwarded to you upon receipt of payment. Decals must be renewed annually and must be attached to each mooring above the waterline prior to use of the mooring. Prior to the beginning of boating season you will receive a mooring decal renewal form each year requesting the \$25.00 mooring decal fee and a copy of your current processed boat registration.

**NOTE: RSA 270:63 Transfers of Mooring Permits Prohibited:**

- I. A mooring permit shall not be construed as ownership of any real or personal property and shall not be transferred to any other person or location by gift, sale, lease, or rent.**
- II. No person shall charge or be charged for the use of a mooring by any other person.**
