Target: 2-FBI Q target or similar proportion silhouette target. Instructor verbally delegates target(s)

Scoring: Rifled Slug- Use scoring rings. Assign a value of 2 points to scoring area of highest value, 1 point to area of next highest value and no value to rest of target.
Buckshot- 2 points per hit on entire silhouette for #9 pellet buckshot, or 1.5 points per hit for #12 pellet loads.
