Dear Governor Sununu and Council:

I am pleased to present to you this 175<sup>th</sup> Annual Report of the Bank Commissioner. As required by RSA 383:15, this report contains background information on each entity under the supervision of the Banking Department, lists the significant events and issues we addressed during the year, and highlights important statistics and trends regarding the industries regulated by the department.

In 2019, New Hampshire's strong economy continued to support a variety of financial institutions. The financial condition of New Hampshire-chartered banks and credit unions remained good, with solid capital and net worth positions to support growth and absorb losses. The Banking Department continued to consider a new, or "de novo," bank during the year. Several new depository branch offices and interstate branch officers were established. However, continued consolidation within the banking industry was evident as one New Hampshire-chartered bank was acquired by an out-of-state institution.

In order to attend to the increasing number of chartered nondepositary trust companies, the Trust Supervision Division worked towards improving efficiency and effectiveness through a risk-focused trust examination process and advanced fiduciary and risk management training for examination staff. Additionally, nondepositary trust companies continue to utilize advanced information technology solutions to provide services to consumers and, in response, the Department participated in a nonbank cyber security examination program developed by the Conference of State Bank Supervisors.

Licensed consumer credit companies continue to expand in New Hampshire which is a trend seen nationwide. The Department continues to work toward better efficiency and cost savings through regulatory coordination efforts in partnership with other state and federal agencies. An increased focus on technology solutions has been an ongoing goal of the Consumer Credit Division. In furtherance of that goal, the Consumer Credit Division successfully participated in a pilot program for a software solution to improve coordination of resources and help facilitate information sharing for enhanced regulation of licensees that operate in multiple states.

The employees of the Banking Department are proud of their contribution to the State of New Hampshire. Thank you for your trust in us as we pursue the department's statutory mission to protect consumers through effective and efficient regulation of the entities under the department's jurisdiction.



## **Foreword**

The one hundred seventy-fifth annual report of the Bank Commissioner contains management, financial information, banks' locations, credit unions, and other financial institutions operating under a state charter. This report also contains information concerning debt adjusters, money transmitters, mortgage bankers and brokers, mortgage servicers, retail sellers, sales finance companies, and small loan lenders.

## **Mission Statement**

The New Hampshire Banking Department is committed to protecting the public's interest through the professional supervision of the financial services it regulates.

## **Functions of the Banking Department**

The Bank Commissioner is responsible for the general supervision of all New Hampshire chartered and licensed financial institutions through the New Hampshire Banking Department's operation. The Banking Department contains five divisions: Banking, Trust Supervision, Consumer Credit, Legal, and Operations.

The Banking and Trust Supervision Divisions charter, supervise, and examine all state-chartered banks, credit unions, trust companies, and family trust companies in New Hampshire.

The Consumer Credit Division licenses, examines, and regulates companies that provide consumer credit, such as mortgage bankers, mortgage brokers, mortgage servicers, retail auto sellers, sales finance companies, money transmitters, debt adjusters, and small loan lenders.

Working in conjunction with the Banking, Trust Supervision, and Consumer Credit Divisions, the Legal Division investigates consumer complaints and unlicensed or unchartered activity. The Legal Division may commence enforcement actions against financial entities that violate state or federal laws or regulations. The Bank Commissioner has the authority to order consumer restitution as part of those enforcement actions.

The Operations Division supports the daily functions of the Banking Department.
