Dear Governor Sununu and Council:

I am pleased to present to you this 172nd Annual Report of the Bank Commissioner. As required by RSA 383:15, this report contains background information on each entity under the supervision of the Banking Department and lists the significant events and issues we addressed during the year.

You may notice a few changes from previous Banking Department Annual Reports, many of them resulting from the recodification in 2015 of nearly all statutes under the jurisdiction of the Banking Department. For instance, in previous reports, the state-chartered banks under our supervision were categorized as commercial banks, co-operative banks, guaranty savings banks or mutual savings banks. Regulatory evolution has dissolved the practical differences between those charter types and recodification made the change official. Therefore, we now simply list those institutions as "Banks".

While this report shows that consolidation continues its steady march via mergers and acquisitions in the banking and credit union markets, it also shows that the effort to make New Hampshire one of the most desirable states in the nation to charter non-depository fiduciary trust companies is bearing fruit as their numbers are growing steadily.

Work at the Banking Department often requires a great amount of dedication and resolve. A case in point is the effort on the part of many department employees and appointed representatives to unwind the failure of Noble Trust Company. Nine years after astute Banking Department examiners uncovered a Ponzi scheme perpetrated by the founder, his victims have begun to receive a percentage of their principle investment back. This is a good news story made possible by dogged determination to see this wrong corrected. A short history of Noble Trust Company in Liquidation is enclosed in this report.

Finally, the Banking Department was very pleased this year to celebrate the promotion of Emelia A.S. Galdieri, Esq., our former General Counsel, who was approved by the Honorable Governor and Counsel to serve as Deputy Commissioner of the Banking Department. For that, and your ongoing faith and support of our efforts, we thank you.

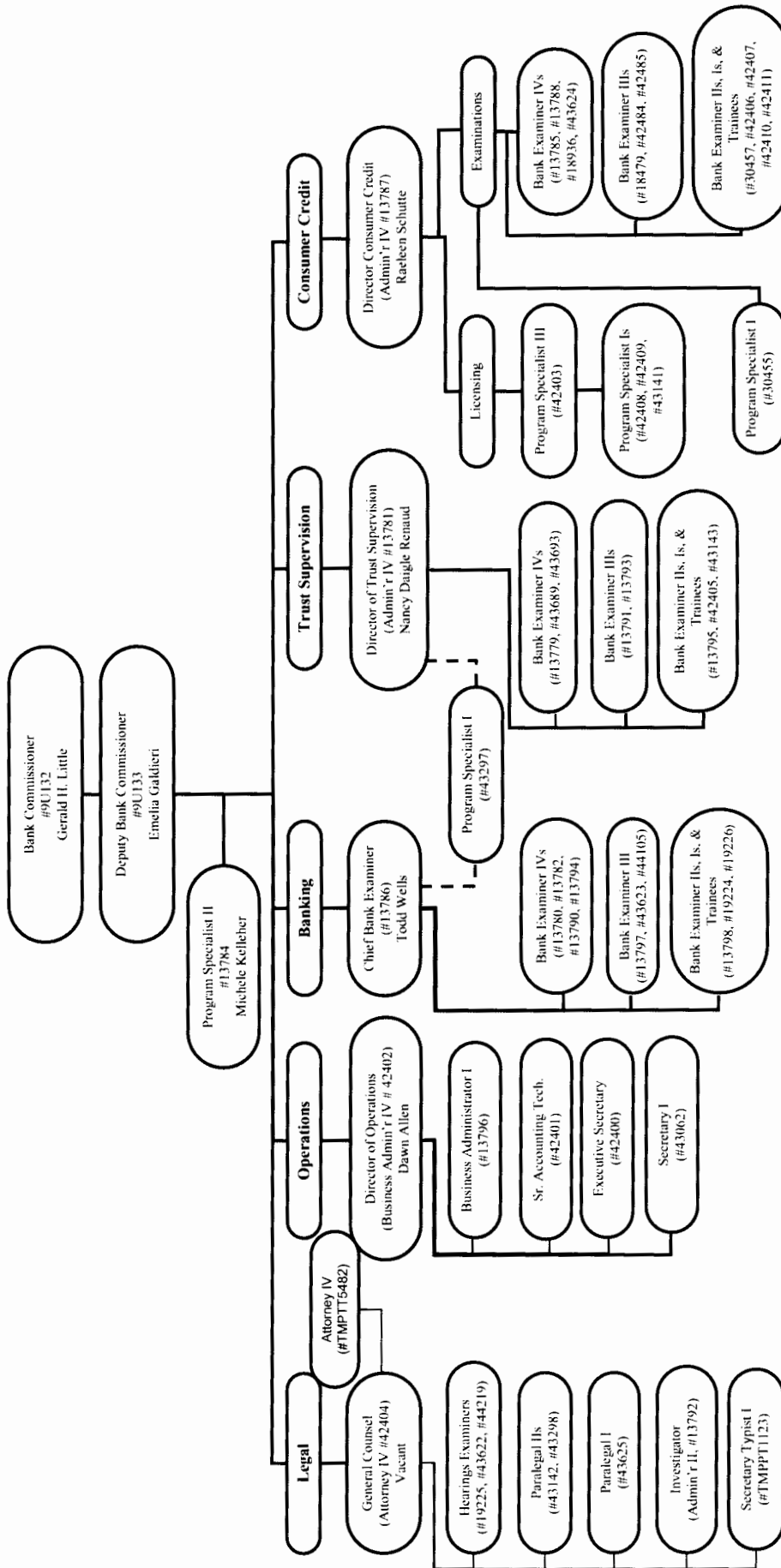

Foreword

The one hundred seventy-second annual report of the Bank Commissioner contains management, financial information and locations of banks, credit unions, and other financial institutions operating under state charter. This report also contains information concerning debt adjusters, money transmitters, mortgage bankers, mortgage brokers, mortgage servicers, retail sellers, sales finance companies, and small loan lenders.

Mission Statement

The New Hampshire Banking Department is committed to protecting the public's interest through the professional supervision of the financial services it regulates.

Functions of the Banking Department

The Bank Commissioner is responsible for the general supervision of all New Hampshire chartered and licensed financial institutions through the operation of the New Hampshire Banking Department. The Banking Department contains five divisions: Banking, Trust Supervision, Consumer Credit, Legal, and Operations.

The Banking and Trust Supervision Divisions charter, supervise, and examine all state-chartered banks, credit unions, trust companies, and family trust companies in New Hampshire.

The Consumer Credit Division licenses, examines, and regulates companies that provide consumer credit, such as mortgage bankers, mortgage brokers, mortgage servicers, retail auto sellers, sales finance companies, money transmitters, debt adjusters, and small loan lenders.

Working in conjunction with the Banking, Trust Supervision, and Consumer Credit Divisions, the Legal Division investigates consumer complaints and unlicensed or unchartered activity. The Legal Division may commence enforcement actions against financial entities that violate state or federal laws or regulations. The Bank Commissioner has the authority to order consumer restitution as part of those enforcement actions.

The Operations Division supports the daily functions of the Banking Department.

Noble Trust Company in Liquidation

Noble Trust Company (NTC) was organized and chartered in 2003 under New Hampshire law as a non-depository banking corporation. As a result of irregularities discovered in 2008 by the Banking Department during a regular examination, the Bank Commissioner filed a Petition for Liquidation in Merrimack County Superior Court seeking the appointment of a liquidator for NTC pursuant to RSA 395:1, as well as a motion for injunctive relief against the company pending the Court's ruling. The court issued a Temporary Restraining Order (TRO) on February 11, 2008. The Commissioner appointed a Conservator of Noble Trust Company and the TRO enjoined any interference with the Conservator in the performance of his duties, which included taking possession of the books, records, and property of NTC.

On March 27, 2008, the Court entered an order appointing the Bank Commissioner liquidator of both NTC and its parent company, Aegean Scotia.

The Liquidator concluded that, in its early days, NTC invested a substantial portion of its clients' money in a Ponzi scheme. In order to hide its losses from its clients and regulators, NTC itself became a Ponzi scheme. Following considerable efforts to document the complex, multi-layer, multi-party enterprise a Plan of Liquidation was submitted to the Court, which approved the Plan on October 7, 2014.

The Liquidator has negotiated with numerous parties to resolve various disputes, resulting in Court-approved settlement agreements and, in turn, the collection of settlement sums which, along with the other liquidated assets, will be used to make payments to the victims of NTC's illegal operations. While there are still ongoing efforts to collect and maximize assets for distribution to claimants, these efforts are substantially complete and the Liquidator has moved into the next phase, which is to pay certain Allowed Claims in accordance with the formula set forth in the Plan while maintaining the appropriate reserve for future distributions.

On June 29, 2017, the Liquidator filed a motion to authorize and approve the first partial distribution under the Plan. As of that filing and pursuant to the court-approved Plan, after reserving for all claims filed that are not yet Allowed Claims plus \$2,000,000 for administrative costs, the Liquidator had approximately \$2,000,000 in Cash Available for Distribution. The liquidator estimated that the initial distribution would result in certain claimants recovering approximately 23% of their principle invested.

The initial distribution was approved by the Court on June 30, 2017, and the Liquidator has begun to make distributions. Under the terms of the Plan, the Liquidator anticipates making additional partial distributions and a final distribution in the upcoming months.

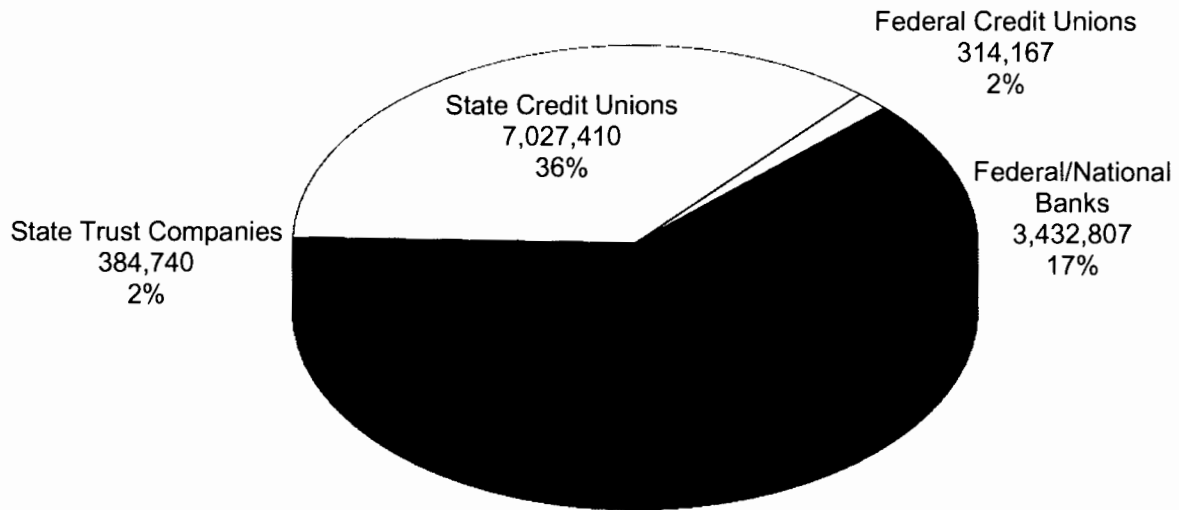

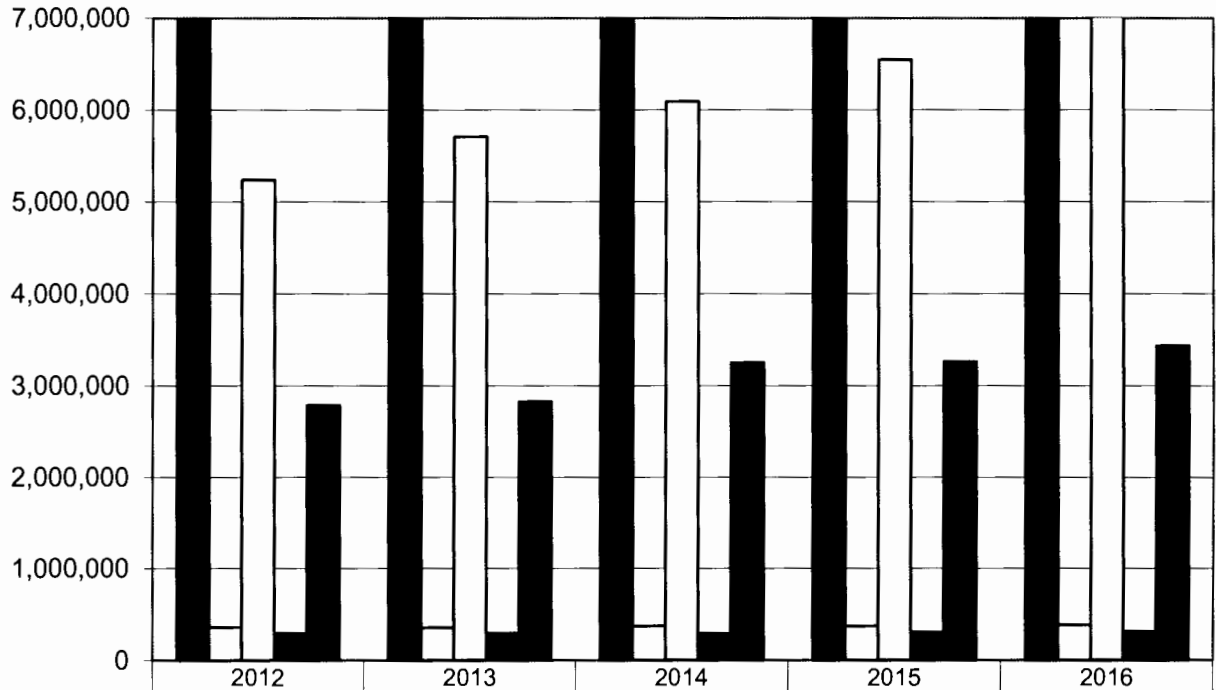

(\$ thousands)**

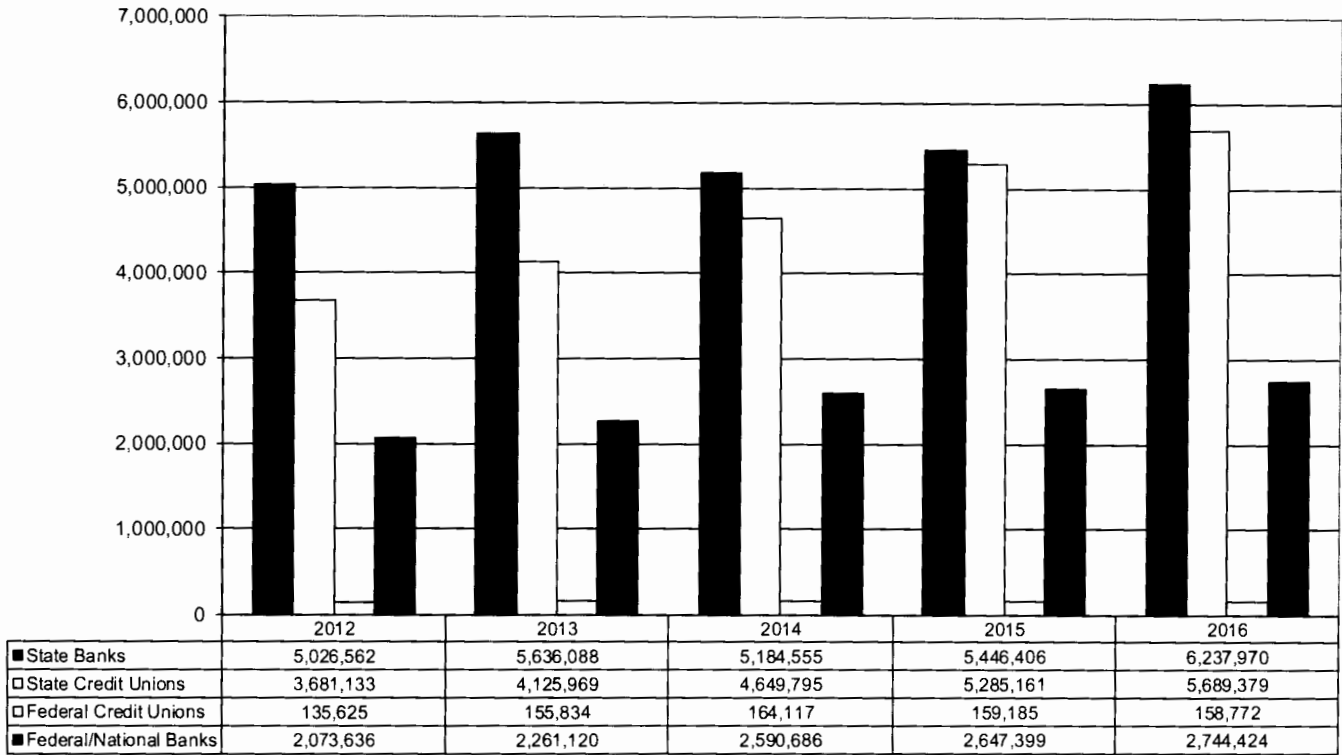


**NH Asset Distribution - Five Year Trend
(\$ thousands)**

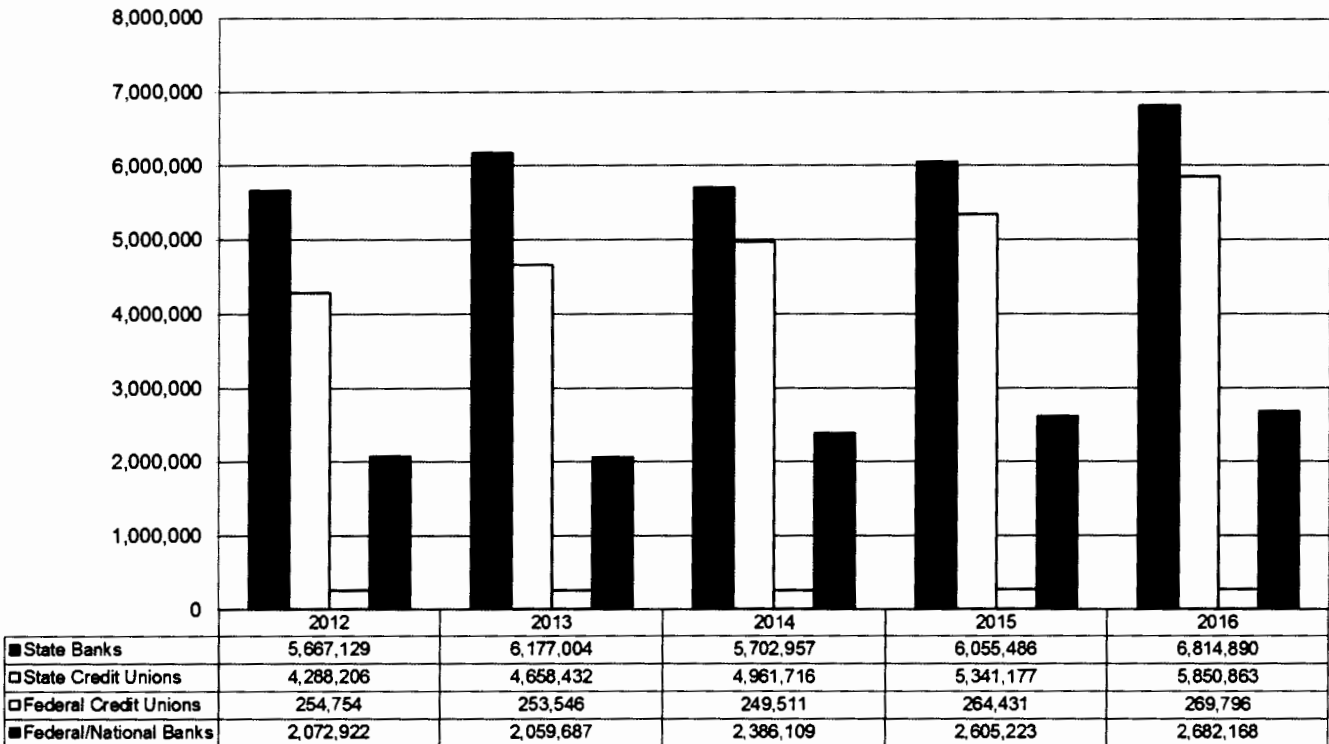

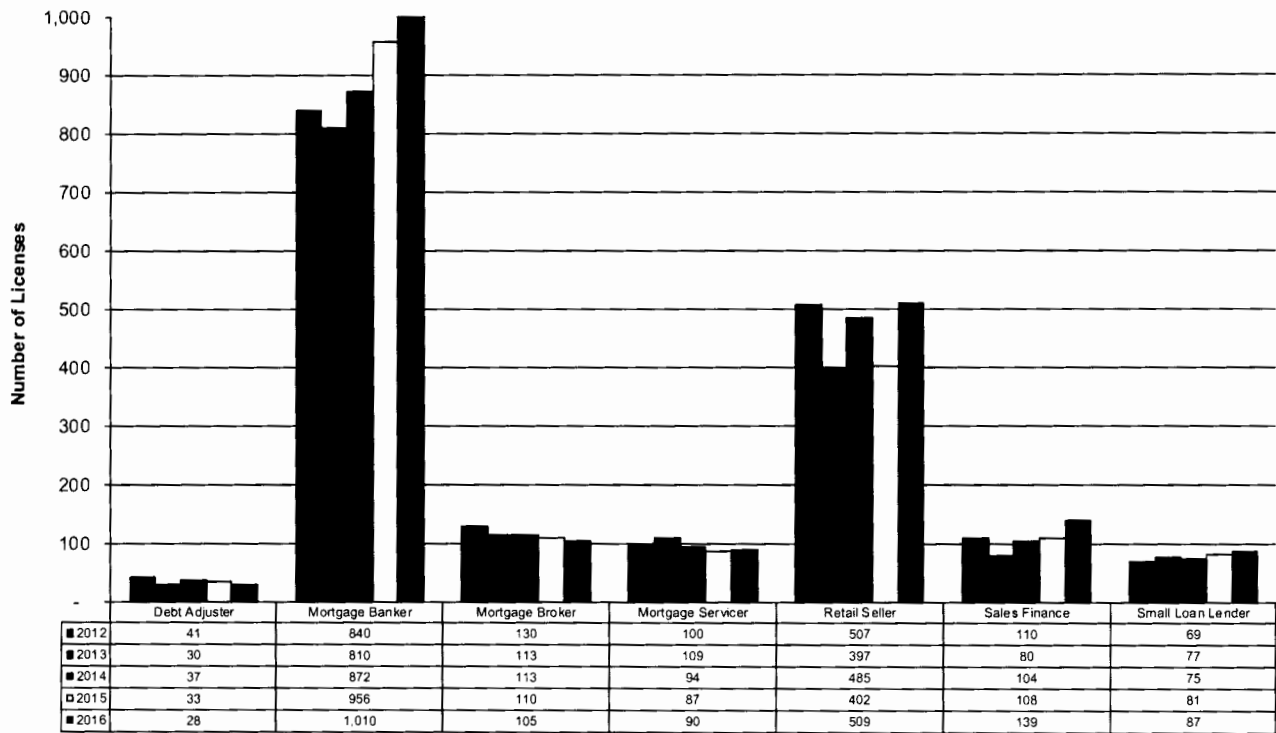
NH Loan Trend - Five Year

(\$ thousands)

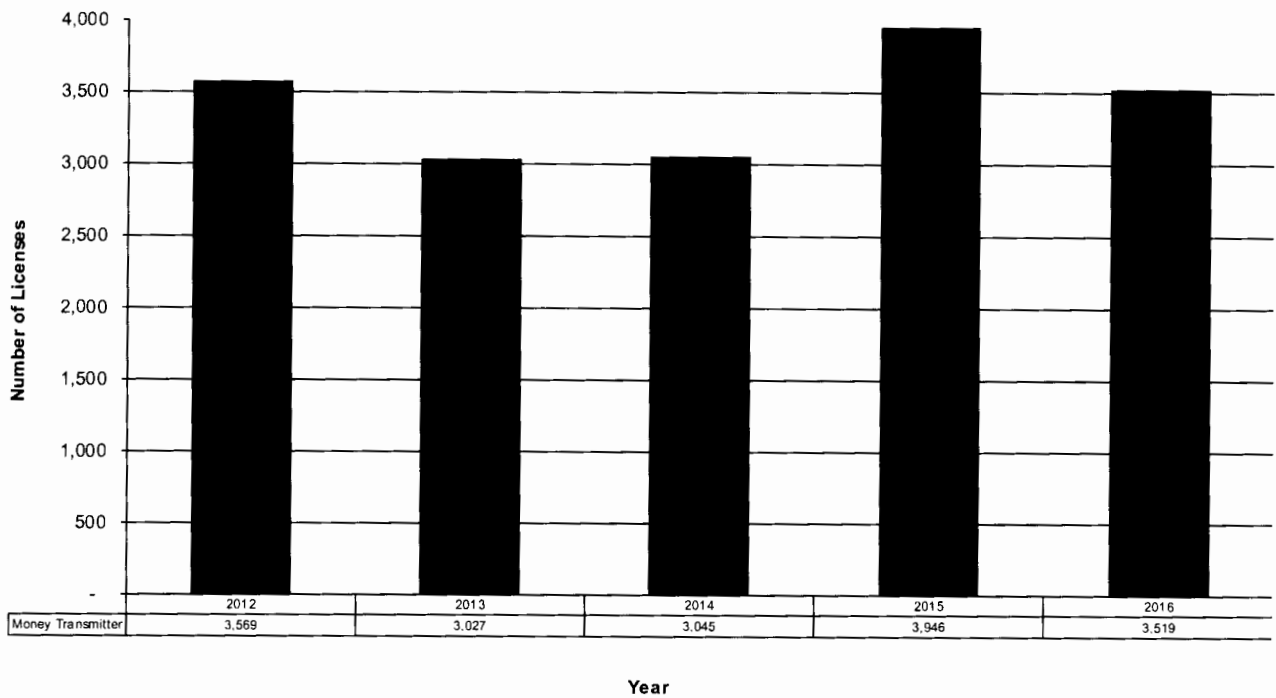

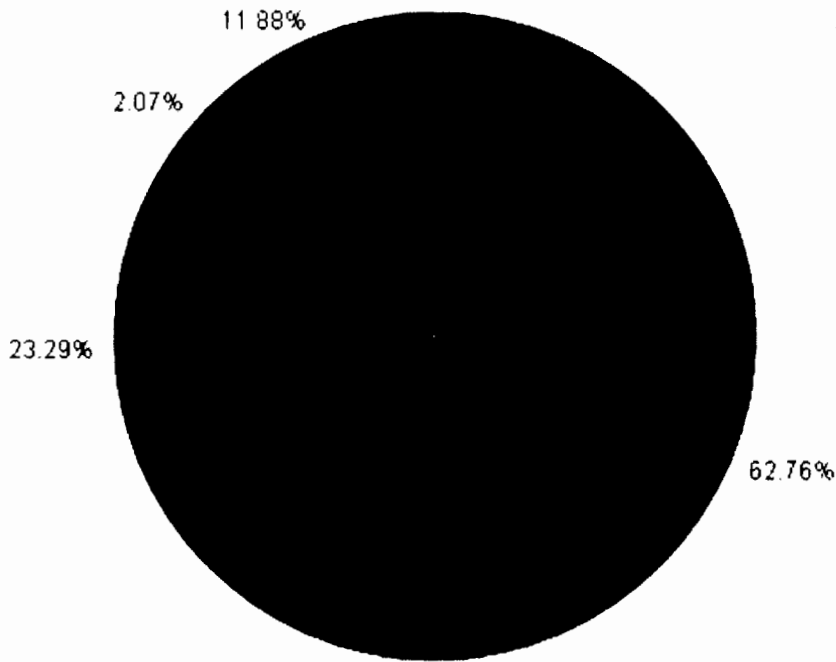

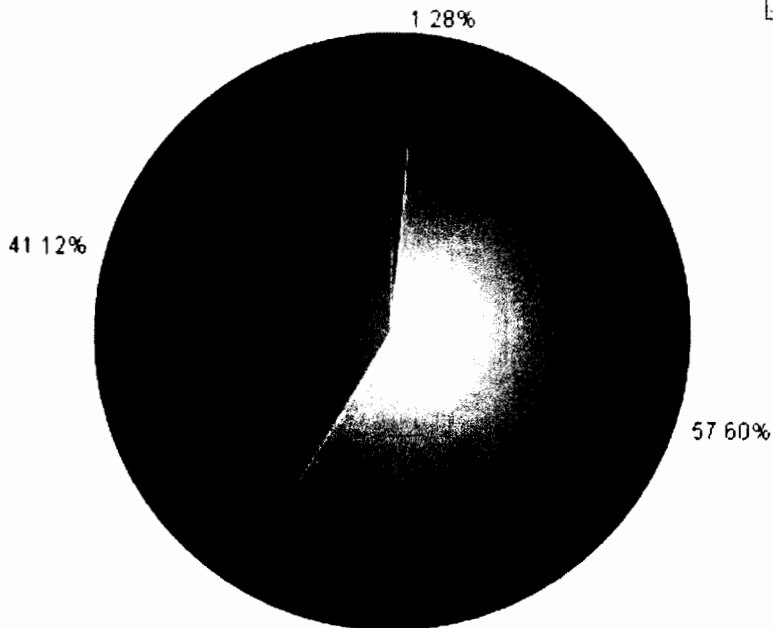

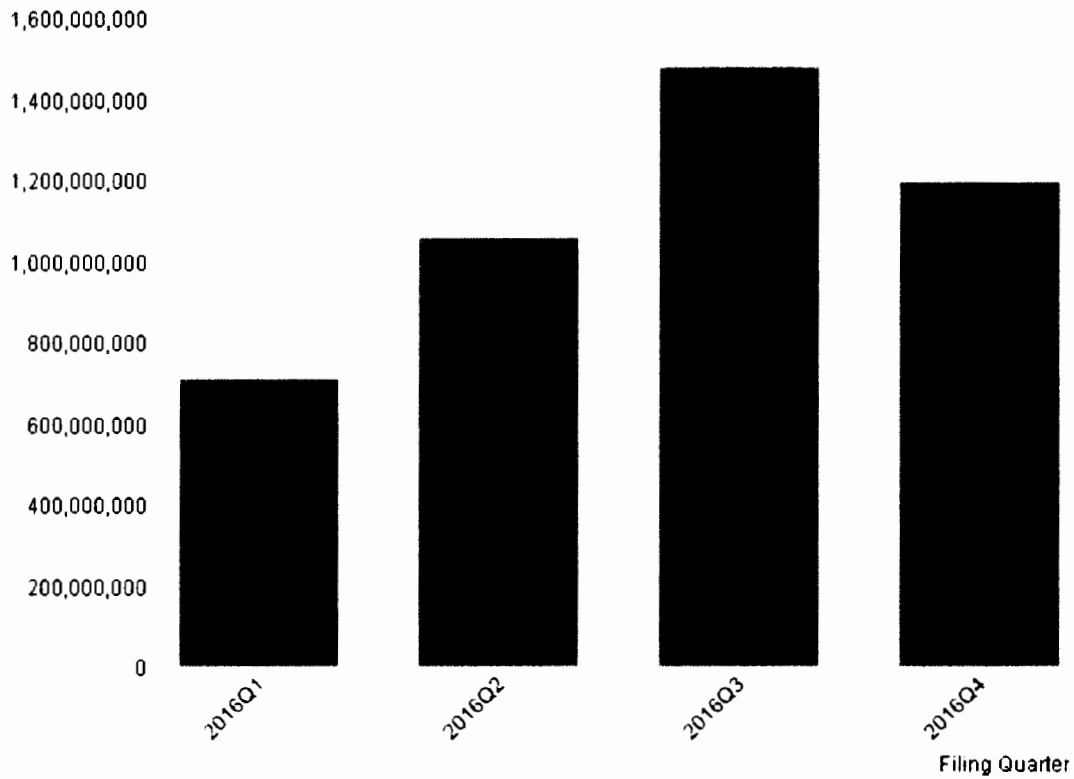

Mortgage Loans by Purpose

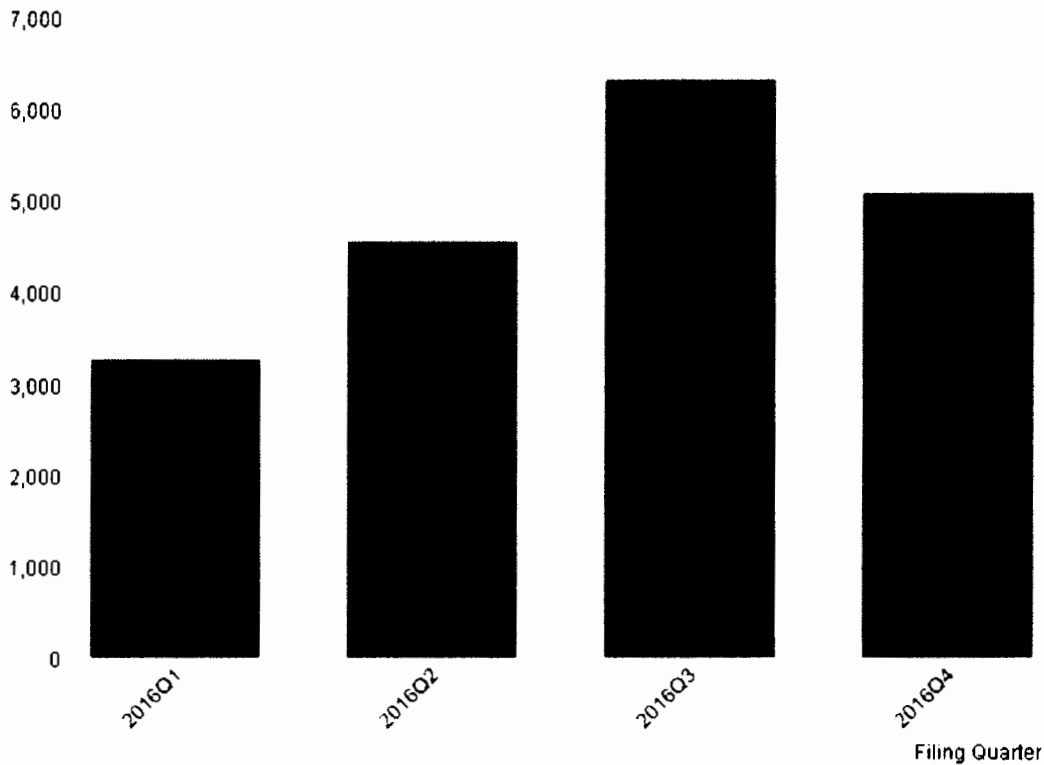
