## TAX CREDIT PROGRAM

[CDFA awarded tax credits to twenty projects throughout New Hampshire](#) in June 2023. The funds will have a significant impact on initiatives that advance local community economic development goals and build capacity across the state. Projects receiving tax credits are: providing increased access to critical services, housing and quality, affordable childcare; revitalizing neighborhoods and historic structures in rural communities; and supporting community economic development efforts.

## CDFA AWARDS MORE THAN \$11.5M FOR COMMUNITY CENTERS

[CDFA awarded more than \\$11.5 million](#) in Community Center Investment Program resources to New Hampshire nonprofits and municipalities advancing community-based projects. These funds allow for deeper impacts within New Hampshire communities with one-time, strategic investments in critical infrastructure. Community Center Investment Program resources will support the enhancement of current indoor and outdoor facilities, as well as the construction of new spaces, that have proven to be inclusive, open to the public, and foster a culture of health and wellbeing in the communities they serve. The [final round of applications](#) for the Community Center Investment Program are due November 30, 2023.

## CDFA LAUNCHING FAMILY-BASED CHILD CARE PROGRAM

CDFA is [launching a Statewide Family Child Care Workforce Pilot Program](#) that will focus efforts on supporting family-based child care providers. These providers play a pivotal role in increasing equitable access to quality, affordable child care for New Hampshire families. The one-year pilot program will also provide an understanding of the current landscape of supports and opportunities for family-based child care providers to help inform how New Hampshire may approach the development and implementation of a Staffed Family Child Care Network as a long-term solution for the sector.

## COUNCIL ON HOUSING STABILITY ADOPTS NEW DATA MODEL

New Hampshire's Council on Housing Stability recently adopted the State's Fair Share Housing Production Model's estimated production numbers, which are based on assessments by the state's nine Regional Planning Commissions and New Hampshire Housing. The Fair Share Housing Production Model estimates a community's anticipated housing production need based on that area's projected population and employment growth; that estimate is that the State of New Hampshire will need an additional 88,395 housing units by 2040.
