*CALL TO ORDER:

The November 19, 2018 Board of Managers Meeting was called to order at 9:02 a.m. by Paul Lloyd, Chairman of the Board of Managers. Attendees present were led in the prayer by Robert Blais and Pledge of Allegiance by Chairman Lloyd.

*PUBLIC HEARING ON ADMINISTRATIVE RULES:

The New Hampshire Veterans Home Board of Managers held a Public Hearing on Administrative Rules Ve-H 200 **Procedural Rules** and Ve-H 300 & Ve-H 400, **Residency, Admission, Transfer and Discharge Rules** at its meeting today beginning at 9:00 a.m.

*APPROVAL OF MINUTES - OCTOBER 15, 2018:

The Minutes of the Board of Managers Meeting of October 15, 2018 were reviewed and discussed. Motion was made by Robert Blais, seconded by Raymond Goulet, Jr., to accept the Minutes of the October 15, 2018 Meeting. M/C.

*COMMUNICATIONS:

Commandant LaBrecque read a letter from Cerdric Marsh, Chairman – U.S. Navy Birthday Committee, Kearsarge-Sunapee Region for the Committee, thanking her for facilitating the attendance of our Navy veterans at their annual Navy Birthday celebration.

*CUSTODIAL FUND INVESTMENTS:

Jason Belanger, Program Specialist IV – NH Department of Treasury, presented CD rates as of 11/16/18.

*CENSUS UPDATE:

As of November 14, 2018, the Home has 183 admitted veterans. Tarr/Welch has 21 veterans approved in the candidate pool. LEDU has 10 veterans approved in the candidate pool. The Home has 71 active applicants.

*BUDGET UPDATE:

Commandant LaBrecque reviewed the FY19 (July 1, 2018 - June 30, 2019) Financial Summaries of the New Hampshire Veterans Home as of October 31, 2018.

Pursuant to RSA 9:7, hearings on agency operating budget requests for the FY 2020-2021 Biennium began on Friday morning, November 16, 2018 in Rooms 306-308 of the Legislative Office Building. Commandant LaBrecque and Armand Plourde presented the Veterans Home's proposed operating budget to members of the Governor's budget advisory panel on Friday, November 16 at 11:30 a.m.

*CAPITAL PROJECTS REPORT:

Armand Plourde provided an update on the New Hampshire Veterans Home's efforts to date concerning capital projects and operational highlights including: • VA Equipment Upgrade Project - \$1,650,000 - Project will start on 11/26/18 with construction of walkway and laundry pad prep. • Town Hall Video System upgrade - State Purchasing Bid 89-19 closed on 10/24/18 at 11:00 a.m. Maverick Systems was the only bidder. Purchasing is issuing the Purchase Order. • Security upgrade project \$795k - Engineers and architects are meeting today for the second walk-through of our facility. • Laundry Department Domestic Hot Water Tank Replacements - Governor & Council approved the contract on 11/14/18 for Northern Peabody in the amount of \$83,000. The contract is for replacing 2 hot water tanks which are leaking and must be replaced within 90 days per the Department of Labor Boiler Inspector. We received another extension until 12/15/18. • Temporary Nursing Services RFP – The bid questioning period closed on 11/15/18 at 2:00 p.m. We received 125 questions from 24

vendors. Bid closing deadline is 11/28/18 at 2:00 p.m.

Michelle Booker, Director of Resident Care Services, provided a Quality Assurance Report of the progress for the past quarter and will share updated information with the Board on a quarterly basis – February, May, August, and November. This presentation was done in a Power Point format.

*RESIDENT/STAFF MATTERS:

A Resident Activity Summary of the many trips and activities during the period of 10/15/18 - 11/19/18 was reviewed.

A Request for Proposal for Temporary Nursing Services at the New Hampshire Veterans Home was issued on 9/19/18 - NHVH RFP 19-01. An Amendment was added to this RFP so we extended the deadlines as follows: Vendor inquiries deadline changed from 10/19/18 to 11/15/18 at 2:00 p.m. Posting of all vendor responses deadline changed from 10/26/18 to 11/19/18 at 2:00 p.m. The deadline for submitting proposals has been changed from 10/31/18 to 11/28/18 at 2:00 p.m.

At its meeting of November 14, 2018, the Governor & Executive Council authorized for the New Hampshire Veterans Home to accept and expend funds from the Community Health Service Network, in the amount of \$5,000 to provide workforce incentives to assist with the regional workforce crisis - effective upon G&C approval through June 30, 2019.

*ADMINISTRATIVE RULES:

No one from the general public attended today's Public Hearing on the Veterans Home's Administrative Rules. Commandant LaBrecque shared Office of Legislative Services Attorney Michael Morrell's comments to Initial Proposal 2018-173 (Ve-H 203, 204, 206, 220).

Motion was made by Raymond Goulet, Jr., seconded by Denise DeBlois, to adopt as final the changes - with the Office of Legislative Services attorney's comments - to the Initial Proposal to Administrative Rules Ve-H 203, 204, 206, 220 – Board of Managers of N.H. Veterans Home – PROCEDURAL RULES. M/C.

Motion was made by William Bertholdt, seconded by Raymond Goulet, Jr., to adopt as final the changes - with the Office of Legislative Services attorney's comments - to the Initial Proposal to Administrative Rules Ve-H 300 – Board of Managers of N.H. Veterans Home – RESIDENCY AND ADMISSION TO NEW HAMPSHIRE VETERANS HOME. M/C.

Motion was made by Robert Blais, seconded by William Bertholdt, to adopt as final the Initial Proposal to Administrative Rules Ve-H 400 – Board of Managers of N.H. Veterans Home, TRANSFER AND DISCHARGE FROM THE HOME. M/C.

Chairman Lloyd and Commandant LaBrecque attended the Fiscal Committee Meeting on Friday, October 19, 2018 to discuss the audit of the State of New Hampshire Internal Control Review of the New Hampshire Veterans' Home Members' Administration Account for the nine months ended March 31, 2018. The Committee accepted the audit, with updates to be provided to the Committee on a quarterly basis.

Commandant LaBrecque and Armand Plourde conducted interviews for the Business Administrator IV on Thursday, November 15, 2018 and will move quickly to select the most qualified candidate.
