#### **\*CENSUS UPDATE:**

As of December 11, 2019, the Home has 172 admitted veterans. Tarr/Welch has 22 veterans approved in the candidate pool. LEDU has 16 veterans approved in the candidate pool. The Home has 78 active applicants.

# **\*BUDGET UPDATE:**

Commandant LaBrecque reviewed the FY20 (July 1, 2019 - June 30, 2020) Financial Summaries of the New Hampshire Veterans Home as of November 30, 2019.

# \*CAPITAL PROJECTS REPORT:

Armand Plourde provided an update on the New Hampshire Veterans Home's efforts to date concerning capital projects and operational highlights including: • Security Upgrade Project and Top of the Fire Wall Repair - \$857k; • Backup Generator Panel Wiring; • Nurse Call System, and • Heat Pump Replacement Project - \$1,170,000 (General Funds 100%); • HVAC Upgrade Town Hall; • Sprinkler System Deficiency Project; and • Dining Room Curtains were discussed. Motion was made by Raymond Goulet, Jr., seconded by William Bertholdt, to purchase the new curtains. M/C. Resident Clutter Policy was discussed and what steps the NHVH has taken to address this issue. Fire Marshall report was discussed and how deficiencies will be addressed. Motion was made by Raymond Goulet, Jr., seconded by Christopher Peirce, to remove the Ranges on the LEDU units. M/C. Town Hall stage laptop plug in directly to overhead projector repair was discussed. Motion was made by Raymond Goulet, Jr., seconded by Oliver Brooks, to make the repair. M/C.

# **\*RESIDENT/STAFF MATTERS:**

A Resident Activity Summary of the many trips and activities during the period of 10/21/19 - 11/18/19 was reviewed and the period of 11/19/19 - 12/16/19.

Michelene Robichaud was "welcomed" to the position of Assistant to the Commandant and Sarah Stanley was "welcomed" to the position of Program Information Officer.

#### \*ROOM & BOARD DAILY RATE REVIEW:

Commandant LaBrecque discussed the analysis of the daily cost of room and board at the New Hampshire Veterans Home. The last increase for the Full Pay rate was from \$300.00 to \$320.00 (a 7% increase) which was effective January 1, 2018. Currently, our residents are on average paying \$100.65 per day/\$3,019.35 per month based on their monthly income. Motion was made by Raymond Goulet, Jr., seconded by Susan Cuddy, to leave the Full Pay rate at \$320.00. M/C.
