## \*CALL TO ORDER BY CHAIRMAN:

The October 16, 2023, Board of Managers Meeting was called to order at 9:01 a.m. by Paul Lloyd, Chairman of the Board of Managers. Attendees presents were led in prayer by Robert Blais, Chaplain for the Board of Managers, and the Pledge of Allegiance by Chairman Paul Lloyd.

#### \*APPROVAL OF MINUTES – September 18, 2023:

The Minutes of the Board of Managers Meeting from September 18, 2023 were reviewed, and discussed. Motion was made by Raymond Goulet, Jr., seconded by Robert Blais to accept the minutes. #### \*COMMUNICATIONS:

NHVH New Addition – Commandant MacKay reported her, and Brian Baker will be meeting with the Architects/Engineers today to do the walk through and additional discussion on the project. They have a projected time frame of the spring of 2026 for the completion of the project.

Commandant MacKay reported that we have no residents with Covid and 1 staff the tested positive this weekend. We will be providing Covid vaccines for our residents, once available. Staff are being asked to go to their local pharmacies or their provider for them. We will not be providing them for staff this year, but they are covered under their state health coverage plan.

Residents have already received their flu vaccines last week, and we did offer it to any staff at our wellness fair on October 11, 2023. They can also obtain a flu vaccine from their providers.

#### \*CAPITAL PROJECTS REPORT:

Commandant MacKay and Brian Baker provided an update on the New Hampshire Veterans Home's efforts to date concerning capital projects and operations highlights:

- Staff Update Safety & Security Supervisor, Shane McNutt has accepted the position.
- **RK Pond Paving Project** Once the contract has been approved by G&C we will move forward with the project.
- **Tarr North Drain Problem** Will start on October 17, 2023. They should be completed by October 31, 2203. This will allow use of the Tarr North tub room and kitchenette again.
- Eversource Lighting Project Meeting on Friday October 13, 2023. They will be replacing all lights & fixtures at the facility with a low-energy LED light. Eversource stated we should see a decrease in our electric bill by half once the project is completed by December 2023.
- **Parking Lot Project** Meeting today to discuss the design changes that will need to be done, due to the new addition project. This is still projected to be done in the spring of 2024.
- **Door Overhangs and Site Drainage Project** They have been sent to Public Works for design and resolution of our water problem in the buildings, to then be put out to bid.
- **Pond Fountain** Has been ordered, once received it will be installed in the pond in the spring.
- **Diversion Door Project** The project is taking a bit longer than anticipated, due to the door prep needed before the application can be installed.

 VA Survey – Testing of all electrical equipment, should be completed by the end of the day today. Once completed we will submit our completed corrective action plans to the VA in hopes of being moved from provisional status to full compliance status.
