Dear Residents and Families -

In these unprecedented times, I am reaching out to keep you up to date with information about procedures we have implemented to keep your Veteran healthy.

We continue to operate under Governor Sununu's declared State of Emergency due to the novel coronavirus (COVID-19) pandemic. The ability to once again visit the NH Veterans Home will be addressed by the Governor and the NH Department of Health and Human Services (DHHS) by May 4, 2020. In the interim, we continue to address the many facets of the pandemic daily and work hard to protect our Veterans; it is our top priority. I continue to communicate regularly with the Governor and his staff to keep abreast of the latest information. Our Infection Control Coordinator also remains in close contact with the DHHS professionals.

As mentioned in our letter last month, the Centers for Disease Control and Prevention (CDC) states that nursing home populations are at the highest risk of being affected by COVID-19, including being at increased risk of serious illness if infected with the virus that causes the disease. We continue to closely monitor recommendations made by the CDC, DHHS, and the Governor's Office, and continue to implement all possible measures for our Veterans' health and safety. One such measure is to screen all employees as they enter the building; we check temperatures and ask screening questions provided by the CDC.

Cleanliness and disinfecting remain a priority. Our Xenex ultraviolet light germ-killing robot works to cover smaller enclosed areas while the Clorox magnetic spray machine is utilized for open areas. Approved disinfectants are used throughout the facility, especially in high-touch areas.

We continue to conduct scheduled activities, as they are an important part of residents' quality of life. These activities have been reviewed for optimal benefits while considering safety; social distancing and disinfection of shared objects is incorporated.
