Dear Residents and Families,

In my letter last month, I wrote to inform you of residents who tested positive for COVID-19. At this time, I am writing to inform you that the residents who previously tested positive, have returned to their rooms from the quarantine unit.

Thankfully, no residents have recently tested positive for the virus. Unfortunately, we received notification that two of our employees tested positive for the virus as a result of our mandatory testing.

Because of this, we are still in outbreak status by the NH Department of Health and Human Services. This status remains in effect until we have two weeks of negative test results.

We understand this impacts our veterans' ability to visit with you, especially during this time of a continued pause on social excursions. We have revised our compassionate care visits in order to accommodate our veterans' needs. While we continue to schedule visits in as many ways possible, the following options are available:
